I, ______ [print name], ACKNOWLEDGE THAT BY SIGNING THIS DOCUMENT, I AM RELEASING THE SECURITY INDUSTRY ASSOCIATION (SIA) AND THEIR RESPECTIVE AGENTS, EMPLOYEES, MEMBERS, SPONSORS, PROMOTERS AND AFFILIATES (COLLECTIVELY "RELEASEES") FROM LIABILITY. THIS ASSUMPTION OF RISK, LIABILITY WAIVER AND RELEASE IS A CONTRACT WITH LEGAL CONSEQUENCES. I HAVE BEEN ADVISED TO READ IT CAREFULLY BEFORE SIGNING.

In consideration of the Releasees admission to me to participate in the above event, I hereby freely agree to and make the following contractual representations and agreements. I acknowledge that motor cycle riding is an inherently dangerous sport and fully realize the dangers of participating in the Ride for education and FULLY ASSUME THE RISKS ASSOCIATED WITH SUCH PARTICIPATION INCLUDING, by way of example, and not limitation, the following: the dangers of collision with pedestrians, vehicles, other riders, and fixed or moving objects; the dangers arising from surface hazards, including pot holes, equipment failure, inadequate safety equipment, THE RELEASEES' OWN NEGLIGENCE, THE NEGLIGENCE OF OTHER MOTORISTS AND PARTICIPANTS, and weather conditions; and the possibility of serious physical and/or mental trauma or injury, or death associated with riding a motorcycle. For myself, my heirs, executors, administrators, legal representatives, assignees, and successors in interest (collectively "Successors") I HEREBY WAIVE, RELEASE, DISCHARGE, HOLD HARMLESS, AND PROMISE TO INDEMNIFY AND NOT TO SUE the Releasees and the sponsors of this event, the organizer and any promoting organizations, and their respective agents, officials, and employees through or by which the events will be held, (the foregoing are also collectively deemed to be Releasees), FROM ANY AND ALL RIGHTS AND CLAIMS INCLUDING CLAIMS ARISING FROM THE RELEASEES' OWN NEGLIGENCE, which I have or which may here after accrue to me and from any and all damages which may be sustained by me directly or indirectly in connection with, or arising out of, my participation in or association with the event, or travel to or return from the event.

I understand that SIA has not undertaken any duty to inquire into, examine or otherwise make any determination with respect to the quality and safety of the any of the motorcycles or other equipment rented to participants by Las Vegas Harley Davidson ("LVHD"). SIA makes no guarantee or assurance of any kind, with respect to the equipment rented by LVHD to the participants, or with respect to the route, sites or events included in the "Ride for Education". I hereby acknowledge that I have received the Notice and Assumption of Risk, and that I have read, understand and accept the risks outlined therein.

I agree, for myself and my successors, that the above representations are contractually binding, and are not mere recitals, and that should I or my successors assert a claim in contravention of this agreement, the asserting party shall be liable for the expenses (including legal fees) incurred by the other party or parties in successfully defending. This agreement may not be modified orally, and a waiver of any provision shall not be construed as a modification of any other provision herein or as a consent to any subsequent waiver or modification. I consent to the release by any third party to Releasees and their insurance carriers of my name and medical information that may relate solely to any injury or death I may suffer arising from the event. Every term and provision of this agreement is intended to be severable. If any one or more of them is found to be unenforceable or invalid, that shall not affect the other terms and provisions, which shall remain binding and enforceable.

NOTICE AND ASSUMPTION OF RISK

I,______ [print name], represent that I am fully knowledgeable concerning the dangers and hazards associated with riding motorcycles. I know that there are natural and man-made obstacles or hazards, surfaces and/or environmental conditions, including but not limited to, potholes, road construction, road debris, animals, traffic, acts of third parties, wind, rain, sleet, hail, snow, heat and cold and said risks in combination with my own actions or the actions of other riders, can cause me severe personal injury, death and/or property damage. I understand that the choice of wearing a safety helmet or other protective gear is solely my own. I agree that I, and not the Security Industry Association (hereinafter "SIA"), its employees, servants, agents and/or assigns, am responsible for my safety during my participation in the Ride for Education.

I HEREBY RELEASE AND DISCHARGE, on behalf of myself, my heirs, executors, personal representatives and/or assigns, Security Industry Association, and its organizers, promoters, sponsors, owners, directors, administrators, employees, servants, agents and/or assigns from any and all actions, causes of action, claims, demands, damages, injuries and liabilities of any nature whatsoever (including reasonable attorney's fees) arising out of or in any manner connected with their involvement in the Ride for Education.
